RESOLUTION NO. 108

"WHEREAS, there is a proposed vecinal road from Ormoc City to barrio Sto. Niño, the appropriation for which is ready for expenditure as soon as the road right-of-way of the proposed route will be completed;

"WHEREAS, one of the landowners along the proposed route of the said vecinal road, Mr. Filomeno Torres and also some others, have repeatedly refused to sign the road right-of-way agreement; and

"WHEREAS, there is no other possible way by which the land along the route can be utilized for the proposed road, than by expropriating the same;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to request the Honorable Executive Secretary, Malacañang, to authorize the City Attorney, Ormoc City to proceed with the expropriation proceedings over a parcel of land owned by Mr. Filomeno Torres and others, for the vecinal road from Ormoc City to barrio Sto. Niño;

"CARRIED, Unanimously."


