RESOLUTION NO. 113

"WHEREAS, one Mr. Flaviano Maglasang, a prospective rice & corn mill operator appeared before this Board to report that the City Treasurer, this City, has repeatedly refused to issue him a license to operate a rice & corn mill despite his willingness to pay whatever taxes may be required of him for the operation of said mill;

"WHEREAS, this Body understands that the City Treasurer has refused the issuance of the requested license in view of the zonification ordinance passed by this Board, the effectivity of which, was by an amendatory resolution, set on July 5, 1962;

"WHEREAS, in spite of the limited time left for the operation of his mill, Mr. Maglasang has manifested before this Body his willingness to avail of the opportunity during the few years left for his mill to operate, after which he will transfer to the prescribed industrial zone; and

"WHEREAS, after conducting an ocular inspection on the mill of Mr. Maglasang, this Body is convinced that he should be given consideration on his request to operate in view of the expenses he has already incurred for the improvement of his mill;

"NOW, THEREFORE, the Board, on motion of Councilor Samson, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to direct the City Treasurer, this City, to issue the necessary license for the operation of a rice and corn mill to Mr. Flaviano Maglasang, subject to the following conditions:

(a) That the sound-absorbing device now installed in the mill should be kept in a perfect working condition while the mill is in operation;

(b) That the dust and smoke emitted by the mill should be so controlled so as not to spread in the vicinity of the mill or its neighborhood;

(c) That failure to comply with these conditions will subject his permit to operate the mill to revocation;
