RESOLUTION NO. 117

"WHEREAS, the Ormoc City High School which is now and in fact operating for the last nine years, has no building and school site of its own;

"WHEREAS, as of the present there is available and ready for expenditures an amount sufficient for the construction of a city high school building but that said construction has not been undertaken in view of the lack of a sufficient high school site which will meet the requirements of the Bureau of Public Schools; and

"WHEREAS, this Body is aware of an army reservation at Camp Downes, this City, which this Body has thought of requesting His Excellency, the President of the Philippines to set aside a portion of said army reservation consisting eight hectares, for the Ormoc City High School site;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to request His Excellency, the President of the Philippines, to set aside a portion of the army reservation at Camp Downes, Ormoc City, covering an area of eight hectares for the Ormoc City High School site, and on which the building of said school will be constructed;


"RESOLVED FINALLY, to furnish copies of this resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; the Secretary of Education, Manila; the Director of Public Schools, Manila; the Division Superintendent of Schools, Tacloban City; and the Principal, Ormoc City High School, Ormoc City.

"CARRIED, Unanimously."


