RESOLUTION NO. 120

"WHEREAS, in view of the approval by the Secretary of Finance of the city budget of Ormoc City for the fiscal year 1953-1954, several positions have been given increases, one of such positions, that of the Sergeant of the Fire Department, which was raised from ₱960 to ₱1,200 per annum effective Oct. 17, 1953;

"WHEREAS, the position of Sergeant of the Fire Department was then occupied by Mr. Perfecto M. Leyson at the date the budget was approved - Oct. 17, 1953 - , until February 11, 1954 when he was terminated from the service by then Acting City Mayor Roberto B. Almaden; and

"WHEREAS, Mr. Perfecto M. Leyson, at the time he was terminated from the service, was not able to enjoy the salary increase because when he received his approved appointment bearing the salary increase he was already out of the service; and

"WHEREAS, this Body sees that Mr. Leyson is still entitled to collect the said salary difference;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to authorize the City Treasurer, Ormoc City, to pay the salary difference of Mr. Perfecto M. Leyson, Sgt., Fire Department, from Oct. 17, 1953 to Feb. 11, 1954, at ₱20.00 per month, from the salary savings of any department of the city government;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the Chief, Fire Department, and Mr. Perfecto M. Leyson, all of Ormoc City.

"CARRIED, Unanimously. "
