RESOLUTION 10. 127

"WHEREAS, one-half of the present site of the Maungen Community School is owned by the spouses Tomas Oroc and Concepcion Cabahug and the other half owned by one Juan Quilantans, deceased, succeeded by a grand daughter;

"WHEREAS, according to Mrs. Concepcion Oroc, the donation of their lot, known as Lot No. 5191 of the Ormoc Cadastre, under TCT No. 2553, had been affected prior to the last world war, but that there were no papers of donation to formalize the same;

WHEATAS Mr. & Mrs. Orec manifested their willingness to execute a Deed of Donation in favor of the city government of Ormoc for the lot above-mentioned stating that whe will only retain 400 sq. m. which is now occupied by her house; and

WHERENS, the above named couple further manifested that the owners of the other half of the said land are also willing to execute a Deed of Donation in flavor of the city for their share of the donation;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to request the City Attorney, Ormoc City, to draft the necessary Deed of Donation in favor of the city government in connection with the present site of the Naungan Community School said Deed of Donation to be signed by the spouses Tomas Oroc and Concepcion Cabahug who owns one-half of the entire lot; Provided however, that the said spouses will retain 400 sq. m.; and another Deed of Donation with respect to the other half which belongs to Juan Quilantang, deceased, but who has a grand daughter who is also willing to sign said Deed of Donation;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Attorney, the City Treasurer, the City Auditor, and the spouses Tomas Oroc and Concepcion Cabahug of Naungan, Ormoc City.

"CARRIED, Unanimously."
