RESOLUTION NO. 132

"WHEREAS, acting on the request of the barrio officials and residents of barrios Alegria and Batuan, this City, in connection with the operation of their barrio school which was newly opened, this Board, by resolution, reserved Lots Nos. 2455 and 2513 of the Ormoc Cadastre which are decreed public lands, for the school site of the said barrios;

"WHEREAS, unofficial reports received by this Board are that after the passage of the above-mentioned resolution reserving Lots Nos. 2455 and 2513 for school purposes, a certain Pedro Vasquez, of barrio Alegria, filed an application for the ownership of a portion of these lots; and

"WHEREAS, even the aggregate area of these two lots is a little short of the requirements of the Bureau of Public Schools for a standard school site, so much so that by granting ownerships to private parties over these lots or even portions of them only, would greatly hamper the functions of the school which is now in full operation;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to request the Bureau of Lands, Manila, to disapprove the application of Mr. Pedro Vasquez of Ormoc City, or any other private party, for the ownership of Lots Nos. 2455 and 2513 or portions of them, for the reason that the same have been reserved by the City of Ormoc for school site of the barrio school of Alegria;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Director of Lands, Manila; the District Land Officer, Tacloban City; and the Bureau of Lands representative, Ormoc City.

"CARRIED, Unanimously."
