RESOLUTION NO. 135

"WHEREAS, Asst. City Attorney Fermin S. Maglasang has been designated Acting City Attorney of Ormoc City by Administrative Order No. 111 of the Secretary of Justice during the absence of the regular incumbent, with compensation as provided by law for said position;

"WHEREAS, it has come to the knowledge of this Board that regular incumbent Ramon An. Torres has resigned and has accrued in his favor vacation and sick leaves extending up to September 30, 1959; and

"WHEREAS, the difference in salary between the rates provided for the position of City Attorney and that of the Assistant City Attorney (P425 and P200 per month, respectively) is P225.00, which amount must be supplied during the period of leave of the regular incumbent so that the Assistant City Attorney can receive the compensation provided for the position of City Attorney, as per above mentioned Adm. Order;

"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Samson;

"RESOLVED, as it is hereby resolved, ^{to} appropriate the sum of P675 from out of the salary savings of any department, to be made available for the salary of the Asst. City Attorney as Acting City Attorney, to supplement the rate provided for the former position, during the months of July, August and September, 1959;



"CARRIED, Unanimously!"


