RESOLUTION NO. 136

"WHEREAS, in a letter addressed to His Honor, the City Mayor, dated August 6, 1959, Commissioner Eliseo C. Alinsug of the Court of Agrarian Relations, this City, requested the restoration of the telephone line to the Court;

"WHEREAS, it may be recalled that sometime last year the telephone connection to said Court was cut off due to lack of funds for the purpose; and

"WHEREAS, although the CAR is established in Ormoc City, it is operated and maintained by the national government and what the Commissioner is asking the city to finance is only the telephone service for which this Body opines that the installation of same would redound to the benefit of the people in general;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱120.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the monthly dues of a telephone installation in the Court of Agrarian Relations, this City, from September 1, 1959 to June 30, 1960;




