RESOLUTION NO. 139

"WHEREAS, in a letter addressed to the City Treasurer, this City, the Officer-In-Charge, Prosecution Division, Department of Justice, Manila, asked information whether or not Ormoc City is able and willing to pay the bills for expenses of a Special Prosecutor from Manila to Ormoc and during his stay here to investigate ex-parte the case arising from the strike in the Ormoc Sugar Company;

"WHEREAS, according to the same letter, it is the Executive Secretary, Malacañang, who requested the Department of Justice to send a Special Prosecutor to Ormoc City to investigate; and

"WHEREAS, in order to apprise Malacañang of the true facts of the case, it is but proper ^{that} a representative from the Department of Justice be sent to Ormoc City to investigate;


NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱250.00 from out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the traveling and subsistence expenses of a Special Prosecutor from the Department of Justice, Manila, to Ormoc City to investigate the case above-mentioned;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Officer-In-Charge, Prosecution Division, Department of Justice, Manila; the City Treasurer and the City Auditor, both of Ormoc City.

"CARRIED, Unanimously."


