"WHEREAS, this Board has received an advice from the Divtrict Supervisor, Ormoc District I, that the Division Superintendent of Schools has released the share of Ormoc City from the proceeds of the last Provincial Athletic Neet held here last December 2-6, 1958, in the amount of \$2,073.29, less the amount of \$35.04 used in buying materials for the construction of bleachers, or a net amount of \$2,038.25; and

PISOLVED FARMER, that this amount of \$2,038.25 may be withdrawn by the District Supervisors of Ormoc I & II to cover the necessary expenses in preparation for the next provincial Athletic Meet that may be held here either in October or November this year; Provided however, that the City will continue to receive the share that may accrue from the proceeds of said Provincial Meet;
