RESOLUTION NO. 140

"WHEREAS, this Board has received an advice from the District Supervisor, Ormoc District I, that the Division Superintendent of Schools has released the share of Ormoc City from the proceeds of the last Provincial Athletic Meet held here last December 2-6, 1958, in the amount of ₱2,073.29, less the amount of ₱35.04 used in buying materials for the construction of bleachers, or a net amount of ₱2,038.25; and

"WHEREAS, the District Supervisor has requested that this amount, after being deposited with the Office of the City Treasurer, be made available for withdrawal to defray expenses in running the next provincial athletic meet which is expected to be held here sometime either in October or November, this year;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to authorize the City Treasurer, this City, to receive the amount of ₱2,038.25 representing the share of Ormoc City from the proceeds of the last Provincial Athletic Meet held here last December 2-6, 1958, as a trust fund deposit;

"RESOLVED FURTHER, that this amount of ₱2,038.25 may be withdrawn by the District Supervisors of Ormoc I & II to cover the necessary expenses in preparation for the next Provincial Athletic Meet that may be held here either in October or November, this year; Provided however, that the City will continue to receive the share that may accrue from the proceeds of said Provincial Meet;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisors of Ormoc I & II; the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED, Unanimously."
