RESOLUTION NO. 142

"WHEREAS, during the widening of city streets, particularly at Mabini Street, the City used and occupied 38 sq. meters of Lot No. 616 under OCT No. 13458, in the name of Restituto O. Cabiling to widen the said city street;

"WHEREAS, the road right-of-way agreement executed by and between the City Mayor in representation of the City and Mr. Restituto Cabiling, landowner, stipulated payment of the lot used and occupied by the aforementioned city street at the rate of ₱15.00 per square meter, in accordance with the rate fixed by the Appraisal Committee; and

"WHEREAS, the landowner, Mr. Cabiling, is now claiming payment of the land in accordance with the agreement, and for which this Board feels it an obligation of the City to compensate for Mr. Cabiling's property used for road purposes;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Penserga;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of Mr. Restituto Cabiling, the particulars of which are described above; hereby authorizing the City Treasurer, Ormoc City to pay the said land at ₱15.00 per square meter or an aggregate amount of ₱570, as soon as funds are made available for the purpose;



"CARRIED, Unanimously."


