RESOLUTION NO. 145

"WHEREAS, during the construction of Bonifacio Extension the City used and occupied 1,170 square meters of Lot No. 1387 of the Cadastral Survey of Ormoc, owned by Mr. Hermogenes Sanchez;

"WHEREAS, in compensation for the property of Mr. Sanchez used for road purposes, the City has made two partial payments already, per Vouchers Nos. 2259 and 3213 both at ₱1,842.00 or an aggregate total of ₱3,684.00 collected by Mr. Sanchez as partial payment; and

"WHEREAS, inasmuch as the total original claim was ₱7,020.00 and the partial payments amounted to only ₱3,684.00 there is still therefore, a balance payable to Mr. Sanchez in the amount of ₱3,336.00; and

"WHEREAS, Mr. Sanchez had made representations with this Board requesting that the balance above mentioned which is rightfully due him, be now released;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"RESOLVED, As it is hereby resolved, to request the City Treasurer, Ormoc City, to pay the balance due Mr. Hermogenes Sanchez for his road right-of-way claim in the amount of ₱3,336.00, should funds be made available for the purpose;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, and Mr. Hermogenes Sanchez, all of Ormoc City.

"CARRIED, Unanimously."




