RESOLUTION NO. 147

"WHEREAS, the barrio officials of Balion, this City, have made representations with this Board requesting this Body's assistance in requesting His Excellency, the President of the Philippines, to allot from out of his Contingent Fund the sum of ₱3,000 for the reconstruction of their school building which has been dilapidated due to incessant rains and typhoons; and

"WHEREAS, this Body understands that the President's contingent fund is primarily intended for typhoon aids;

"NOW, THEREFORE, THE BOARD, on motion of Councilor Du, seconded by Councilor Ocubillo;


"RESOLVED, as it is hereby resolved, to request His Excellency, the President of the Philippines, to allot from out of his Contingent Fund the sum of ₱3,000.00 as typhoon aid to barrio Balion, Ormoc City, for the reconstruction of the barrio school building thereat which has been dilapidated due to incessant rains and typhoons;

"RESOLVED FURTHER, to request His Excellency, the President, that should it be possible, the same amounts be set aside also for the same purpose for the barrios of Nasunogan and Catmon, also of this City;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable Congressman Dominador M. Tan, House of Representatives, Manila; the Honorable Secretary of Education, Manila; the Director of Public Schools, Manila; and the Division Superintendent of Schools, Tacloban City;

"CARRIED, Unanimously."


