RESOLUTION NO. 149

"WHEREAS, barrio Maticaa, this City, has a complete elementary school but it has no Home Economics building which is necessary in the operation of the intermediate classes;

"WHEREAS, even the temporary school building in said barrio is already dilapidating due to incessant rains and typhoons and may collapse anytime during bad weather; and

"WHEREAS, as of the present the city government of Ormoc is not yet in a position to extend to barrio Maticaa the necessary amounts which they requested, i.e., P3,000.00 for the construction of a school building and P2,500.00 for the construction of a Home Economics building;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request Congressman Dominador M. Tan, to ask the President of the Philippines to give from his Contingent Fund the sum of P5,500.00 for the construction of a Home Economics building and a semi-permanent school building in barrio Maticaa, this City;


