RESOLUTION NO. 153

"WHEREAS, during the preparation of the city budget, the City Health Officer, this City, made a recommendation for the creation of a position of Midwife in order to serve expectant mothers especially in the barrios;

"WHEREAS, in view of the precarious finances of the city during the preparation of the budget, the position of Midwife was in the meantime eliminated; and

"WHEREAS, since the City Health Officer has reiterated his request stating that the creation of the said position is very urgent, this Body is convinced that there is really a need of a Midwife in the City Health Department;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to create the position of Midwife in the City Health Department, effective September 1, 1959;


"RESOLVED FURTHER, that the position of Midwife as is hereby created, be provided with a compensation at the rate of ₱1,200 per annum;

"RESOLVED FURTHERMORE, that the amount of ₱1,000.00, be as it is hereby, reverted from the appropriation for Garbage Collection and Disposal, to cover the salary of the midwife from September 1, 1959 to June 30, 1960;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Health Officer, all of Ormoc City.

"CARRIED, Unanimously."




