## RESOLUTION NO. 156

"WHEREAS, Councilor Du monifestal belove the Nody that Barrio Pikoy is now ripe for a complete primary school;

"WHEREAS, at present Pikoy has only Grades I & II but there are several pupils out of school who are eligible for Codes III & IV;

"WHEREAS, the neighboring barrios with complete elementary grades are kilometers way from Piko, with so much inconveniences as crossing the dangerous Pagranga-an River and the muddy rice paddies; and

"WHEN'S, by pring Grades III & IV in barrio Pikoy would end the light of the barrio people for complete primary school and moreover the government would be doing its part in educating our youth even in the remotest part of the country;

W.W. THEREFORE, the Board, on motion of Councilor Marciano S. Du, seconded by Councilor Parrilla;

"RESOLVED, as it is hereby resolved, to request the Division Superint endent of Schools, Tabloban City, to cause to be opened, a complete pringry school in Barrio Pikoy, this City, for the reasons given above;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Director of Public Schools, Manila, for his sanction of the request embodied herein; Congressman Dominador M. Tan, HR, Manila; the Division Superintendent of Schools, Tacloban; the District Supervisor, Ormoc II, and the Barrio Lieutenant, Pikoy, both of Ormoc City.
