RESOLUTION NO. 162

"WHEREAS, when Fireman Quirino Naya was appointed to his position last November 5, 1957, the rate of pay attached to his appointment was only ₱75.00 per month;

"WHEREAS, the city budget for the fiscal year 1957-1958 ending June 30, 1958, carried an annual compensation of ₱960 for each of the firemen, or ₱80.00 per month which the above-mentioned fireman was not able to enjoy; and

"WHEREAS, Fireman Quirino Naya is now presenting a voucher in his favor covering his salary difference at ₱5.00 per month from November 5, 1957 to June 30, 1958 or a total of ₱39.39;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱39.39 from out of the salary savings of the Fire Department, this City, to be made available for the payment of the salary difference of Mr. Quirino Naya, for the period from November 5, 1957 to June 30, 1958, at ₱5.00 per month;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief, Fire Department, all Ormoc City.

"CARRIED, Unanimously."




