"WHEREAS, during the construction of Benifacio Extension, the city used and occupied a portion of the lot owned by Mr. Hermogenes Sanchez, of this City, of which he was paid partially in two vouchers;

"WHEREAS, after the two partial payments Mr. Sanchez has still a balance due and payable by the city in the amount of ₱3,336.00 which he is now asking payment; and

"WHEREAS, in view of the poor finances of the city at present this Body has no way of paying the amount in full, but may be paid partially;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to revert the sum of ₱1,219.00 from out of the ₱3,219.00 appropriated in the current annual budget for transfer to the Roads and Bridge Fund, to the general fund, and that the same be, as it is hereby, appropriated for the payment of the road right-of-way claim of Mr. Hermogenes Sanchez, as a third partial payment;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, and Mr. Hermogenes Sanchez, all of Ormoc City.

"CARRIED, Unanimously."


