RESOLUTION NO. 167

"WHEREAS, the City Mayor has requested an appropriation of ₱2,000.00 to supplement his Discretionary Fund which according to the records in the Office of the City Treasurer, is almost exhausted;

"WHEREAS, this Body will remember that there had been several requests from the barrios for aid which were charged against the Mayor's Discretionary Fund, so much so that the said fund had been depleted to disrupt the program of expenditures for which the said fund had been appropriated; and

"WHEREAS, in view of the foregoing, this Body sees the necessity of supplementing the above-mentioned fund;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to revert the sum of ₱2,000.00 from out of the ₱3,219.00 appropriated in the current annual budget for transfer to the Roads and Bridge Fund, to the general fund, and that the same be, as it is hereby, appropriated, for the Discretionary Fund of the City Mayor;



"CARRIED, Unanimously."




