RESOLUTION NO. 168

"WHEREAS, the appropriations for Police uniform allowance carried in the city budgets of the last two fiscal years had barely been enough for the khaki uniforms only of the policemen, and no amount has been left for the purchase of shoes;

"WHEREAS, for the last two years the policemen had not been given shoes uniforms, so much so that according to the letter of the Chief of Police addressed to this Body dated Sept. 11, 1959, the members of the police force are no longer presentable due to worn out shoes; and

"WHEREAS, sixty-five pairs of Ang Tibay shoes are estimated to cost about P1,075.00;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to revert the appropriation of P1,000.00 for "Repair of building and jail" in the Police Department, to Uniform Allowance, in order that the same could be made available for the purchase of shoes as requested in the aforesaid letter of the Chief of Police;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.

"CARRIED, Unanimously."




