## RESOLUTION NO. 171

"WHEREAS, this Body will remember that in last your's city budget there was incorporated under the Office of the Nunicipal Board an item for Garbage Inspector with a salary of Fl, 440 per annum;

"WHEREAS, during the discussion of this year's city budget the Board had laid down a policy to exclude new positions which were created last year, except the very essential ones as the Market Collectors to belster the collections from the market and the Special Deputy Assessors, to increase real estate tax collections, so that the aforesaid position of Varbage Inspector which at the time of the preparation of the current annual budget was considered not essential, was excluded; and

"Whereas, this Boar finds the necessity of recreating the position of Carbar Inspector, this time to be attached to the Office of the City In in order to supervise the collection and disposal of arbage in the city which is undertaken by private contractors;

"NOW THE FORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Parrilla;

RESOLVED, as it is hereby resolved, to recreate the position of arrage Inspector, this time to be attached to the Office of the City Magineer, this City, with a compensation of \$1,440 per annum, effective upon the approval of this resolution by the City Mayor;

"RESOLVED FURTHER, to revert from out of the F13,000.00 appropriated in the current annual budget for Garbage Collection and Disposal, the sum of P1,140.00, or so much thereof as may be necessary, to cover the salary of the Garbage Inspector, from the effectivity of his appointment to June 30, 1960;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.

"CARRIED, Unanimously."
