RESOLUTION NO. 173

"WHEREAS, in a petition addressed to this Board, the afore-said officials of Valencia are requesting P300.00 more in order to complete the repairs of their school building;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilors Omega and Penserga;




