RESOLUTION NO. 176

"WHEREAS, in the current annual budget the positions of Assistant City Treasurer and Assistant City Auditor are provided with annual compensations at the rate of ₱3,120 each;

"WHEREAS, in accordance with law, and considering that the incumbents of these positions above-mentioned are first grade eligibles, the minimum salaries for said positions should have been ₱3,720.00 per annum each; and

"WHEREAS, in view of the poor finances and the considerably low income of the city government, it had always been a problem to adjust the salaries of employees even to the minimum; however, in the instant case the incumbents of the positions above-mentioned have been agreeable to a partial implementation only of the rates prescribed for their positions, recommending for the purpose, reversions of funds already appropriated;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to revert the sum of ₱700.00 previously appropriated by this Body for the purchase of a motor-bike for the City Auditor, and ₱20.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the salary adjustment of the Assistant City Treasurer and the Assistant City Auditor, the said amount to be divided equally between the two positions and added to the rates of salaries prescribed in the current annual budget, so that the said positions should carry the following adjusted rates:

One : Assistant City Treasurer (from ₱2,640)..... ₱ 3,480.00

One : Assistant City Auditor (from ₱3,000) ₱ 3,480.00

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable Secretary of Finance thru the City Treasurer, Ormoc City; the Honorable Auditor General thru the City Auditor, Ormoc City; and each to the Assistant City Treasurer and the Assistant City Auditor, both of Ormoc City.




