RESOLUTION NO. 177

"WHEREAS, Nasunogan is one barrio in Ormoc City that has several electors but has not polling place or precinct of its own;

"WHEREAS, as Nasunogan has no precinct of its own, its voters are registered all around the adjoining barrios causing them so much inconvenience especially during the rainy season because in the case of voters from Nasunogan registered in Salvacion, they will have to travel about seven or eight kilometers by taking the course of the road or if they prefer to take the shorter route, they will have to cross rivers and muddy rice paddies;

"WHEREAS, the same situation is happening in barrio Milagro where its voters are registered in Hibunaon; that instead of going to Dolores which is nearer and more convenient, they have to go to Hibunaon because they are assigned there;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Omega;


"RESOLVED, as it is hereby resolved, to request the Commission on Elections thru its representative assigned to Ormoc City, that the polling place to which the voters of Nasunogan are assigned in barrio Salvacion be transferred from the latter barrio to barrio Nasunogan itself; the precinct of barrio Salvacion where the voters of Nasunogan are assigned be transferred to the barrio of Nasunogan itself, in order to give convenience to the voters of barrio Nasunogan; and, also the precinct in the barrio of Hibunaon where the voters of barrio Milagro are assigned be transferred to the barrio of Dolores, to be joined with the rest of the precincts in the school building of that barrio;

"RESOLVED FURTHER, that the representative of the Commission on Elections together with the City Treasurer should make an ocular inspection of these places above-mentioned;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Commission on Elections, Manila, thru its representative in Ormoc City; the City Treasurer, Ormoc City; the Chairmen of the Board of Election Inspectors of the precincts concerned; and the Barrio Lieutenants of the barrios concerned.

"CARRIED, Unanimously."


