RESOLUTION NO. 178

"WHEREAS, Councilor Martinez cited the case of an elector who is residing just in front of the school building of Margen whose name has been transferred to San Juan, to his inconvenience, as well as those of several others;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to request the Commission on Elections that its representative in Ormoc City, to retain the old voters in the precinct situated in barrio Margen and to continue the registration of the new voters residing in barrio Margen and within its sitios in that precinct situated in the school building of Margen, and that the new voters to be registered in that precinct situated in the school building of San Juan be those voters residing only in San Juan and its sitios;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Commission on Elections, Manila, thru its representative in Ormoc City; the City Treasurer, Ormoc City; the Chairmen of the Board of Election Inspectors of the barrios Concerned; and the Barrio Lieutenants of the barrios concerned.

"CARRIED, Unanimously."




