RESOLUTION NO. 180

"WHEREAS, during the regular session of this Board held on September 4, 1959, Resolution No. 165 was passed appropriating P300.00 as soon as funds are made available for the payment of the road right-of-way claim of the spouses Felicitas Jayme and Basilio Magno;

"WHEREAS, according to the City Treasurer there are no available funds for the purpose at present; and

"WHEREAS, Mr. Magno has time and again made representations with this Body asking for a specific appropriation for his claim, to the extent of expressing his willingness to accept even half of the total amount of his claim, if at present the city is not yet in a position to pay the whole amount;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to revert from out of the salary savings of the position of Agricultural Adviser and Fertilizer in-Charge in the Office of the City, which is incorporated in the current annual budget but remains unfilled to date, the sum of P150.00, to be made available for the partial payment (half of the total amount) of the road right-of-way claim of the spouses Felicitas Jayme and Basilio Magno;



"CARRIED, Unanimously."




