RESOLUTION NO. 18

"WHEREAS, there are several city employees whose appointments are still pending release in national offices concerned in Manila, like employees in the Fire Department, the Police Department, and some in the city hall;

"WHEREAS, other matters of interest to the city government also pending in Manila, are the fire truck which the National Civil Defense Administration has promised to allot to Ormoc City and the transistor radios distributed to the barrios by the Radio Control Board and for which this City has requested the allocation of one radio each to the barrios in Ormoc City; and

"WHEREAS, this Body has seen the necessity of sending one of the employees of the city in the person of the Secretary to the City Mayor to Manila to follow up all these matters in order to hasten their release;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to authorize the Secretary to the City Mayor, Mr. Lucas de Loyola, to proceed to Manila on official trip at the earliest transportation available, in order to follow up all these matters mentioned in the preceding paragraphs, in order to hasten their release;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and Mr. Lucas de Loyola, Secretary to the City Mayor, all of Ormoc City.

"CARRIED, Unanimously."
