RESOLUTION NO. 182

"WHEREAS, every year during the preparation of the city budget this Body always encounters the difficulty of setting aside an outlay for the operation of the city intermediate schools;

"WHEREAS, this Body has noted that in some cities the operation of the city intermediate schools is financed by the national government; and

"WHEREAS, should the operation of the Ormoc City intermediate schools be taken care of by the national government the city will be able to save at least ₱25,000.00 which could do a lot to improve the city and probably even set the salaries of city employees at the minimum wage;


"NOW, THEREFORE, the Board, on motion of Councilor Pensetga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to request Congressman Dominador M. Tan, to present a bill in the next session of Congress, amending Section 85 of Republic Act 179, otherwise known as the Charter of Ormoc City, so as to nationalize the operation and maintenance of the city intermediate schools of Ormoc City;


