RESOLUTION NO. 184

"WHEREAS, because of the inavailability of funds during the closing of the books of accounts last June 30, this year, the City Treasurer was not able to take up as outstanding obligations an appropriation in the amount of ₱1,000.00 per resolution of this Body numbered 21, passed on February 10, 1959; and

"WHEREAS, the aforesaid appropriation of ₱1,000.00 which was to be given as benefits to the heirs of the late Pat. Guillermo Magno who died in line of duty last January 13, 1959, could not be collected by the heirs in view of lack of supporting papers, i.e., the approval of the claim by the President of the Philippines; and

"WHEREAS, the papers of said claim are now complete and, therefore, payment would then be in order;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to revert from item or account number C-79(26) the sum of ₱547.75 and from account number C-36(a) the sum of ₱452.25, the latter representing salary savings for the positions of three market collectors, to the general fund and appropriated for the payment of the death compensation to the heirs of the late Pat. Guillermo Magno, as originally passed per Res. No. 21, s. 1959;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.
