RESOLUTION NO. 185

"WHEREAS, Mr. Engracio Limosnero, a claimant for a road right-of-way and whose land has been affected by the extension of Bonifacio Street, has filed a motion for reconsideration with the Office of the City Attorney through this Body, regarding the denial of a previous request by Mr. Limosnero for the payment of a differential amount for the land in question, at ₱4.00 per square meter;

"WHEREAS, according to Mr. Limosnero in his letter, his land has been paid only at the rate of ₱2.00 per square meter while the adjoining lots of Mr. Vicente Torres and Mr. Hermogenes Sanchez have been paid at the rate of ₱6.00 per square meter; and

"WHEREAS, the aforesaid denial by the City Attorney of Mr. Limosnero's previous request has been embodied in Opinion No. VIII, s. 1959 dated July 12, 1957, which is now the subject of Mr. Limosnero's motion for reconsideration, so that he may be paid the difference;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilors Omega; and Gutierrez;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer and Mr. Engracio Limosnero, both of Ormoc City.




