
"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Omega;


"RESOLVED FINALLY, to forward this resolution to Congressman Dominador M. Tan, HR, Manila for consideration;

"CARRIED, Unanimously."


