RESOLUTION NO. 187

"WHEREAS, during the widening of city streets the city used and occupied Lots Nos. 648-E & 648-F, the former lot containing an area of 40 sq.m. and the latter 8 sq.m., both lots belonging to the spouses Hermenegildo Serafica and Josefa Soquez; and

"WHEREAS, a road right-of-way claim has been filed by the above-mentioned spouses for the payment of the aforesaid lots at ₱20.00 per square meter, and for which this Body also feels a just obligation of the city to pay these spouses in compensation for their property used for road purposes;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱900.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the road right-of-way claim of the spouses Hermenegildo Serafica and Josefa Soquez, for their lots above mentioned, at ₱20.00 per square meter;



"CARRIED, Unanimously."




