RESOLUTION NO. 188

"WHEREAS, this Body has noted that there are unused appropriations in accounts C-77-15, C-58, C-77-17, and C-77-24;

"WHEREAS, inasmuch as there is no urgent need for the use of the appropriations in the above-mentioned accounts, this Body believes that the said appropriations should be instead used for some other purpose, the necessity of which is considered more urgent; and

"WHEREAS, the barrio people of Matic-a and Liloan are requesting the installation of water pumps in their barrios to ease them of their water problem;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to revert the sum of ₱750.00 from accounts C-77-15, C-58, C-77-17 and C-77-24, to the general fund, the same to be appropriated as barrio aid to the barrios of Maticaa and Liloan distributed as follows:

Maticaa - - - ₱250.00; and
Liloan - - - 500.00

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the Barrio Lieutenant of Maticaa and the Barrio Lieutenant, Liloan, all of Ormoc City.
