"WHEREAS, as provided by law, these shares may be allotted by  
this Board for the maintenance of charitable and health work, based  
upon the recommendation of the City Health Officer; and

"WHEREAS, the City Health Officer has recommended that the ag-  
gregate total of all the checks listed above be used for the purchase  
of garbage boxes to replace the old and broken ones now used along  
the city streets;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez,  
seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to approve the recommenda-  
tion of the City Health Officer as to the disposition of the sweeps-  
takes shares above-mentioned, i.e., to purchase with the sum of P784.85,  
aggregate total of the checks listed above, garbage boxes in order to  
replace the old ones now being used along the city streets;

"RESOLVED FURTHER, that the purchase of these boxes be treated as  
emergency and should be done without public bidding, but only a canvass  
of the prices among local dealers;

"RESOLVED FINALLY, to furnish copies of this resolution each to  
the City Treasurer, the City Auditor and the City Health Officer, all  
of Ormoc City.

"CARRIED, Unanimously."


