RESOLUTION NO. 199

"WHEREAS, during the deliberation of the current annual budget one intermediate teacher, Miss Cleofe L. Espiritu, was not included among those adjusted to ₱2040 per annum based on educational and civil service eligibility qualifications;

"WHEREAS, during the preparation of the said budget the educational qualification of Miss Espiritu on record was only ETC graduate although at the time she was already a BSE (Inv.) graduate;

"WHEREAS, the basic salary given to intermediate teachers who are BSE graduates is ₱1920 per annum, plus ₱60 for Senior Teacher eligibility and another ₱60 for those who have 5 or more years of teaching experience; and

"WHEREAS, Miss Cleofe L. Espiritu has met all these requirements and, therefore, is entitled to ₱2040 per annum, effective as of the 1st day of July, 1959;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to readjust the salary of Miss Cleofe L. Espiritu, a city intermediate teacher, from her present rate at ₱1800 per annum as appearing in the current annual budget, to ₱2040 per annum, effective July 1, 1959;

"RESOLVED FURTHER, that for this purpose, the sum of ₱240.00 be, as it is hereby, reverted from the item 'Reserve for salaries of substitute teachers' under Contingent Expenses of the Ormoc City Intermediate School Fund budget, to cover the salary adjustment of Miss Espiritu from July 1, 1959 to June 30, 1960;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Division Superintendent of Schools, Tacloban; the City Treasurer, the City Auditor, and the District Supervisor, Ormoc I, all of Ormoc City.

"CARRIED, Unanimously."
