RESOLUTION NO. 192

"WHEREAS, during the regular session of this Board on September 18, 1959, Resolution No. 171 was passed, recreating the position of Garbage Inspector, with a monthly compensation of ₱120.00;

"WHEREAS, basing on the aforesaid resolution, the Honorable City Mayor appointed one Mr. Manuel Tan to the position; however, the designation of Mr. Manuel Tan was inadvertently stated as "Garbage Supervisor" instead of Garbage Inspector as provided for in said resolution;

"WHEREAS, in view of the fact that Mr. Tan is not a civil service eligible, he can not occupy a classified position such as the position of Garbage Inspector; and

"WHEREAS, according to the City Treasurer, Mr. Tan may occupy the position only provisionally or under temporary status in the absence of eligibles;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Larrazabal;

"RESOLVED, as it is hereby resolved, to request the City Mayor to revise the appointment of Mr. Manuel Tan, so that his designation as may appear in his appointment, shall be "Provisional Garbage Inspector" instead of "Garbage Supervisor", effective September 18, 1959;



"CARRIED, Unanimously."




