RESOLUTION NO. 193

"WHEREAS, the City Mayor, this City, in a letter to this Body dated October 7, 1959 informed that actual traveling expenses granted to officials and employees of this City are gauged upon the provisions of Memorandum Circular No. 6, dated April 24, 1959 by the Office of the Executive Secretary, which actually reduced the rates from P20.00 to P12.00 per day while in Manila;

"WHEREAS, according to the same letter of the City Mayor, this rate of P12.00 per day while in Manila is insufficient in view of the high costs of living in said city; and

"WHEREAS, it is the intention of this Body that the old rate of P20.00 per day while in Manila, shall prevail and be enjoyed by city officials and employees of this City, when traveling on official business to Manila;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, that by virtue of the powers conferred upon this Board by the autonomy law, otherwise known as Republic Act No. 2264, under the caption "Municipal Boards or City Councils" of Section 3(a), the former per diem rate of P20.00 when traveling on official business to Manila, shall be restored and still applicable to city officials and employees of this City, and that the former rates prescribed as pertains to travel in the provinces and chartered cities than Manila, shall also prevail, effective July 1, 1959.


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer and the City Auditor, both of Ormoc City.




