RESOLUTION NO. 200

"WHEREAS, the Barrio Lieutenant of Pikoy, in behalf of the people of Pikoy and the adjoining sitios, requested this Body through a letter-petition for the purchase of a big G.I. wire long enough to be hung across the Pagsanga-an River to serve as a line through which the people shall pull their way in bancas across the river;

"WHEREAS, the Pagsanga-an River is most treacherous during this rainy season when floods occur every now and then, giving the residents in barrio Pikoy and other sitios difficulty in crossing the said river; and

"WHEREAS, aside from the G.I. wire line, the Barrio Lieutenant also requested the appropriation of a certain amount for the purchase of corrugated iron roofing to partly replace the rotten nipa roofing of their temporary school building;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Omega;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P150.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available as barrio aid to Pikoy, Ormoc City, for the purposes aforesaid;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, and the Barrio Lieutenant of Pikoy, all of Ormoc City.

"CARRIED, Unanimously."


