RESOLUTION NO. 201

"WHEREAS, on May 8, 1959, this Body, through Resolution No. 75, requested the Ormoc Electric Company to extend its facilities to barrio Ipil so that the residents of said barrio may avail of the services and facilities of the Company;

"WHEREAS, acting on the above-mentioned request, the Ormoc Electric Company is now preparing the necessary papers relative to the said extension for the approval of the authorities concerned; and

"WHEREAS, the Manager, Ormoc Electric Company, has submitted for approval of this Board, a plan of transmission and distribution system showing present circuit and proposed extension to barrio Ipil and Borok;

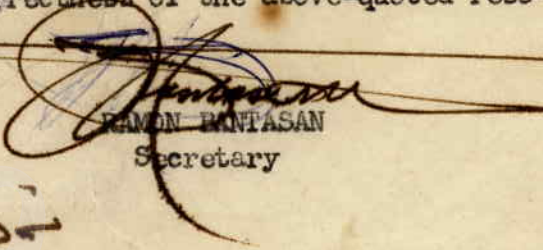
"NOW, THEREFORE, the Board on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"CARRIED, Unanimously."

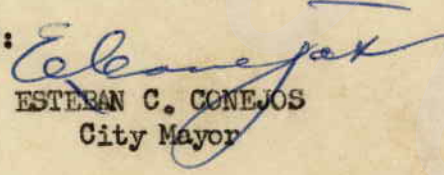
