RESOLUTION NO. 202

"WHEREAS, the teaching force of barrios Linao and Ipil have requested an aid from the city with which to purchase Home Economics equipment for the elementary pupils;

"WHEREAS, Home Economics is one of the important subjects in the public schools curriculum the carrying out of which needs equipments such as kitchen utensils, hand tools and kits for sewing, embroidery, etc.; and

"WHEREAS, these two barrios above-mentioned can not possibly raise the funds needed to purchase the equipment requested by their Home Economics classes in view of financial hardships among its residents;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P300.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available as aid to the intermediate classes of barrios Linao and Ipil for the purchase of Home Economics equipment, and to be apportioned equally between these two barrios or the amount of P150.00 for each;



"CARRIED, Unanimously."




