RESOLUTION NO. 204

"WHEREAS, the Chief, Fire Department, in a letter dated September 18, 1959, invited the attention of this Board that the city government has a share in paying the GSIS insurance and retirement premiums of Fire Department personnel, which this Body has failed to incorporate in the current annual budget;

"WHEREAS, in the same letter the Fire Chief requested the appropriation of ₱275.00 for the purpose; and

"WHEREAS, pursuant to the provisions of Republic Act 660, this Body, or the city government, is obligated to pay its corresponding share of the insurance and retirement premiums of its employees who are insured and compulsory members of the GSIS;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱275.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the government share of the insurance and retirement premiums of employees of the City Fire Department who are insured with the GSIS; for the current fiscal year;




