RESOLUTION NO. 205

"WHEREAS, in last year's city budget (fiscal year 1958-1959), the salaries of the city firemen were increased to ₱1,020.00 per annum each, or ₱85.00 per month; and

"WHEREAS, Fireman Bonifacio Taneo was issued an appointment by the City Mayor at the rate of ₱1,020.00 per annum effective July 1, 1958, in accordance with the said budget, which appointment was submitted to the Office of the President of the Philippines and the Commissioner of Civil Service for approval; and

"WHEREAS, in view of the delay in the approval of the aforesaid appointment of Fireman Taneo by the offices aforementioned, the said fireman was not able to collect his salary difference for the last fiscal year; and

"WHEREAS, Fireman Taneo has already received his appointment at the new rate duly attested and approved by the offices concerned, whereby this Body sees that payment of his salary difference would now be in order;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Martinez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱120.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the salary difference of Fireman Bonifacio Taneo from July 1, 1958 to June 30, 1959;



"CARRIED, Unanimously."




