RESOLUTION NO. 4

A RESOLUTION URGENTLY REQUESTING THE OFFICE OF THE CITY
ENGINEER TO CONDUCT INVESTIGATION AND SURVEY FOR THE
PURPOSE OF DELIMITING THE BOUNDARIES BETWEEN PRIVATE
AND PUBLIC LANDS ON THE PANILAHAN RIVER BED.

"WHEREAS, it has come to the attention of this august
Body that some private persons have fenced with barbed wires
their properties along the Panilahan river, including the
dried-up river bed, so much so that the same are obstructing
the operation of private and public haulers of sand and gra-
vel in that area covering from the mouth of Panilahan river
to the provincial road and from across the provincial road
to the garbage disposal area;


"NOW, THEREFORE, on motion of Councilor Porcadilla,
seconded by Councilor Marquez;

"RESOLVED, to urgently request the Office of the City
Engineer to conduct investigation and survey for the pur-
pose of delimiting the boundaries between private and pub-
lic lands along the Panilahan river, including the dried-
up river bed, from the mouth to the provincial road and
from across the provincial road to the garbage disposal
area, for the benefit of private and public haulers of
sand and gravel in that area;


"RESOLVED, FURTHER, to furnish a copy of this resolu-
