RESOLUTION NO. 9

A RESOLUTION TO CHARGE AGAINST THE SALARY OF PATROLMAN
ADELAIDO HERRERA OF THE ORMOC CITY POLICE DEPARTMENT
THE SUM OF EIGHT HUNDRED FIFTY PESOS (P850.00) TO BE
MADE AVAILABLE FOR PAYMENT OF SERVICES RENDERED BY
HIS COUNSEL, ATTY. MARCIANO S. DU, IN THE COURT OF
FIRST INSTANCE, AS PER ORDER OF SAID COURT IN SPE-
CIAL CIVIL CASE NO. 1127-0 DATED JANUARY 13, 1973

"WHEREAS, the Court of First Instance in Special Civil
Case No. 1127-0 has issued an alias writ of execution dated
January 13, 1973, ordering this august body to appropriate
the sum of eight hundred fifty pesos (P850.00) out of any
salary due Patrolman Adelaido Herrera of the Ormoc City Po-
lice Department, said sum to be made available for payment
of services rendered by his counsel, Atty. Marciano S. Du,
in Special Civil Case No. 1127-0;

"WHEREAS, Patrolman Adelaido Herrera is, again, pre-
sently suspended from service in view of a pending adminis-
trative case against him before the Board of Investigators
of the Police Commission for which he cannot collect his
salary until the termination of his case, aside from five
other members of the Police Department who likewise are
facing administrative charges, with which there will be
sufficient salary savings for reversion to pay Atty. Mar-
ciano S. Du's claim;

"NOW, THEREFORE, on motion of Councilor Kangleon, se-
conded by Councilor Mendola;

"RESOLVED, to charge against the salary of Patrolman
Adelaido Herrera of the Ormoc City Police Department the
sum of eight hundred fifty pesos (P850.00) to be made
available for payment of services rendered by his counsel,
Atty. Marciano S. Du, in the Court of First Instance, as
per order of the said court in Special Civil Case No. 1127-
0 dated January 13, 1973.
