"WHEREAS, the Coart of First Instance in Special Civil Case No. 1127-0 has issued an alias writ of execution dated January 13, 1973, ordering this august Mody to appropriate the sum of eight hundred fifty pesos (#850.00) out of any salary due Patrolan Adelaido Herrera of the Ormoc City Police Paragraphy lice Department, said sum to be made available for payment of services rendered by his counsel, Atty.
