RESOLUTION NO. 10

A RESOLUTION FAVORABLY ENDORSING THE FORESHORE LEASE APPLICATION OF THE ORMOC SUGAR COMPANY OVER A PORTION OF A FORESHORE LAND IN BARRIO IPIL, ORMOC CITY, TO THE BUREAU OF LANDS, AS RECOMMENDED BY THE OFFICE OF THE CITY ENGINEER.

"WHEREAS, the Officer Incharge, Office of the City Engineer, in his 1st Indorsement dated January 17, 1973, to this august Body has recommended approval and disposal of a portion of a foreshore land situated in Barrio Ipil, this city, through lease as applied for by the Ormoc Sugar Company, considering that the land applied for: (1) is intended for expansion and construction of a wharf; (2) is partly under water especially during high tide; (3) will be partly a reclaimed area, the other part being intended for the said wharf construction; and (4) will not adversely affect the drainage system nor obstruct navigation;

"NOW, THEREFORE, on motion of Councilor Aviles, seconded jointly by Councilors Mendola and Tan;

"RESOLVED, to favorably endorse the foreshore lease application of the Ormoc Sugar Company over a portion of a foreshore land situated in Barrio Ipil, Ormoc City, to the Bureau of Lands, as recommended by the Office of the City Engineer;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Director of Lands, Manila; the District Land Officer, Tacloban City; and the City Engineer, Ormoc City; Ormoc Sugar Co., Inc., Ipil, Ormoc City;
