RESOLUTION NO. 12

A RESOLUTION APPROPRIATING THE SUM OF THIRTY-EIGHT PESOS (P38.00) OUT OF FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR FILING FEE IN THE CIVIL ACTION TO QUIET TITLE TO REALTY WITH DAMAGES AGAINST MR. AND MRS. VICENTE BANZON ON LOT NO. 3510 OCCUPIED BY THE MACABUG BARRIO SCHOOL SITE

"WHEREAS, this august Body in Resolution No. 183, series of 1972, has authorized the Office of the City Fiscal to file a civil action in court for quieting title to realty with damages against Mr. and Mrs. Vicente Banzon affecting a portion of Lot No. 3510 situated in Barrio Macabug, this city, which is now being occupied by the school site of said barrio, and for which the Assistant City Fiscal has made representations with this august Body for an appropriation of the sum of P38.00 to cover filing fee in said case;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Mendola and Tan;

"RESOLVED, to appropriate the sum of thirty-eight pesos (P38.00) out of funds existing in the city treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for filing fee in the civil action to quiet title to realty with damages against Mr. and Mrs. Vicente Banzon on a portion of Lot No. 3510 now occupied by the Macabug barrio school site;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, the First Assistant City Fiscal, the Judge of the Court of First Instance, and Mr. and Mrs. Vicente Banzon, all of Ormoc City;
