RESOLUTION NO. 16

A RESOLUTION ENDORSING APPROVAL OF RESOLUTION NO. 5,
SERIES OF 1972, OF THE BARRIO COUNCIL OF BARRIO
HUGPA, ORMOC CITY

"WHEREAS, the Barrio Council of Barrio Hugpa, Ormoc City, in its Resolution No. 5 dated November 14, 1972, would like to avail itself of P1,400.00 out of the Presidential Aid for Rural Improvement and Community Development for the purchase of Lot No. 4105 of the Ormoc Cadastre covered by Transfer Certificate of Title No. 8747 of the Register of Deeds of Ormoc City with an area of 4,996 square meters, more or less, situated in said barrio and belonging to Mr. and Mrs. Jayme Sabino, which lot is adjoining the barrio school site and will be available for the construction of a barrio hall, health center, and multi-purpose pavement, among other urgent community projects;

"NOW, THEREFORE, on motion of Councilor Mendola, seconded by Councilor Tan;

"RESOLVED, to endorse approval of Resolution No. 5, series of 1972, of the Barrio Council of Barrio Hugpa, Ormoc City, and do, as this Body hereby does, authorize the Barrio Captain of Hugpa to purchase Lot No. 4105 containing an area of 4,996 square meters situated in said barrio for the construction of a barrio hall, health center, multipurpose pavement and other urgent projects of the community, availing himself in this connection the sum of P1,400.00 out of the Presidential Aid for Rural Improvement and Community Development of Barrio Hugpa;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, the Register of Deeds, the City Development Officer, PACD, the Barrio Council of Barrio Hugpa, and Mr. and Mrs. Jayme Sabino, Bo. Bantigue, all of Ormoc City;
