RESOLUTION NO. 17

A RESOLUTION AUTHORIZING THE CITY TREASURER TO REVERT THE
AGGREGATE SUM OF TWO THOUSAND FIVE HUNDRED PESOS (P2,500)
FROM OUT OF ANY SAVINGS IN THE VARIOUS DEPARTMENTS TO BE
MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR RECONDI-
TIONING OF DUMP TRUCK FOR GARBAGE DISPOSAL.

"WHEREAS, the garbage truck (Dump Truck Model R-160) is
in dire need of reconditioning so that the Engineering Depart-
ment has submitted its requisition and issue voucher for this
august Body to appropriate the sum of two thousand five hun-
dred pesos (P2,500.00) for the purpose;

"NOW, THEREFORE, on motion of Councilor Porcadilla, se-
conded by Councilor Mendola;

"RESOLVED, to authorize the City Treasurer to revert the
aggregate sum of two thousand five hundred pesos (P2,500.00)
from out of any savings in the various departments, said sum
to be made available as supplemental appropriation for recon-
ditioning of the dump truck for garbage disposal;

"RESOLVED, FURTHER, to furnish a copy of this resolution
each to the City Treasurer, the City Auditor, and the City
Engineer, all of Ormoc City;

"CARRIED UNANIMOUSLY."
